PRODUCER PRICE INDEX FIRST QUARTER 2019

The Kenya National Bureau of Statistics hereby releases the Producer Price Index (PPI) for the first quarter of 2019. Producer Price Index measures the average changes in the prices of products at all stages of processing.

The price changes are measured from the perspective of the producer. The producer prices are collected as at 15th February, 15th May, 15th August and 15th November of the year. These dates correspond to the first, second, third and fourth quarters of the year, respectively.




Figure 1: Year on Year Percentage Changes on Producer Prices

The Producer Price Indices are grouped according to the International Standards of Industrial Classifications of All Economic Activities (ISIC) Rev 4. As shown in Figure 1, the first quarter year on year overall producer inflation was negative 0.36 per cent in March 2019 compared to 1.53 per cent recorded in March 2018.

Table 1 presents percentage changes of producer prices over the previous quarter and the same quarter a year ago. The overall producer prices declined by 1.38 per cent from December 2018 to March 2019 while the 'year on year' inflation was negative 0.36 per cent. Over the last one year, the highest increase was on manufacture of wood and of products of wood which rose by 21.25 per cent followed by manufacture of rubber and plastic products which

rose by 9.66 per cent. However, manufacture of food products and electricity declined by 5.02 per cent and 2.78 per cent during the same period.

Table 2 shows the Producer Price Indices from September 2016 to March 2019. The producer index declined by 0.36 per cent from 120.78 in December 2018 to 118.95 in March 2019. The decrease in the index was mainly due to lower prices of vegetable and animal oils and fats, sugar, tea, grain mill products and electricity.

Producer Prices of Selected Products

Table 3 shows producer prices of selected products in March 2018, December 2018 and March 2019. The price of 20 litres of refined oil declined by 2.9 per cent from KSh 4,596 in December 2018 to KSh 4,461 in March 2019. During the same period, the price of a tonne of sugar declined by 12.4 per cent from KSh 95,041 to KSh 83,284.

Table 4 presents quarterly producer indices from March 2018 to March 2019. The overall producer index decreased from 120.61 points in December 2018 to 118.95 points in March 2019.
