PRODUCER PRICE INDEX FOR THE FOURTH QUARTER, 2023




Figure 1: Producer Price Index and Year on Year Inflation Rates

The Kenya National Bureau of Statistics hereby releases the Producer Price Index (PPI) for the fourth quarter 2023. The quarterly producer prices are denoted by the last month of the quarter and are collected as at the middle of the quarter. The fourth quarter year on year producer inflation was 10.49 per cent in December 2023 which was lower than 16.26 per cent recorded in December 2022. The index rose from 132.07 in December 2022 to 145.92 in December 2023. Trends in the year-on-year Producer Price Index (PPI) and producer inflation from March 2021 to December 2023 are depicted in Figure 1 while Table 1 presents the overall PPI and producer inflation rates from March 2021 to December 2023. Over the period, producer inflation was highest in June 2022.

The year-on-year industrial producer inflation from March 2023 to December 2023 are shown in Table 2. Over the year, the industrial sectors namely: Mining and Quarrying; Manufacturing; Electricity, Gas, Steam and Air Conditioning Supply; and Water Supply, Sewerage, Waste Management and Remediation Activities recorded varying changes in production prices. During the year ending on December 2023, Electricity, Gas, Steam and Air Conditioning Supply sector recorded the highest price increase at 24.2 per cent in December 2023 followed by Mining and Quarrying at 18.5 per cent. Manufacturing recorded a price increase of 9.1 per cent.

Table 3 shows the quarter-to-quarter rate of change in producer price indices. Over the fourth quarter 2023, Mining and Quarrying sector reported the highest price increase of 12.8 per cent. Manufacturing and Electricity, Gas, Steam and Air Conditioning Supply, sectors recorded a price increase of 4.0 and 1.6 per cent, respectively over the same quarter. Price for Water Supply remained unchanged during the same period.

Table 4 presents the percentage changes in producer prices over the same quarter a year ago and between the current quarter and previous quarter. The overall producer prices in December 2023 rose by 3.97 per cent relative to September 2023 prices. Over the same period, manufacture of other non-metallic mineral products recorded the highest price increase of 19.33 per cent while manufacture of leather and related products had the highest price decline of 2.58 per cent. Over the last one year, the highest price increase was

in chemical and chemical products at 30.94 per cent while the highest price decrease was in manufacture of wearing apparel at 6.40 per cent.
